Then IT Scenario

MBank had implemented then core banking software, some five years back. Then CBS implementation was done with incorrect and incomplete data migration. Then CBS software had faulty Data Structure and Data modelling. These improper Data Structure along with incorrect data migration had caused fragmented Data and resulted into several problems in Banking operations management reporting AND lapses in Statutory Compliance Reporting.

Project Objectives:

With failure of then CBS provider in proving support for Master Data Management in CBS system, MBank decided to change its CBS System.
